General Job Information

Job Summary

This position is located in the District of Columbia Department of Health (DC Health), Community Health Administration (CHA), Cancer and Chronic Disease Prevention Bureau (CCDPB), Cancer Programs Division. CHA promotes healthy behaviors and healthy environments to improve health outcomes and reduce disparities in the leading causes of mortality and morbidity in the District. CHA focuses on nutrition and physical fitness promotion; cancer and chronic disease prevention and control; access to quality health care services, particularly medical and dental homes; and the health of families across the lifespan. The CCDPB works closely with health systems, community-based organizations, governmental agencies, and other key partners to provide data, consultation, technical assistance, and leadership to ensure that data-driven, evidence-based, and sustainable approaches are utilized to improve cancer and chronic disease health outcomes among District residents.

The Public Health Analyst (Cancer Epidemiologist) provides epidemiological support and evaluation for the DC Cancer Registry and Cancer Programs Division within the Cancer and Chronic Disease Prevention Bureau. The incumbent uses a data driven approach to support and evaluate the cancer burden in the District.

Major Duties and Responsibilities

Manages all epidemiologic projects of the DC Cancer Registry and Cancer Programs Division. Identifies all cases of malignant neoplasm from disease/diagnostic indexes of reporting facilities to ensure all reportable cases are abstracted into the registry database. Establishes guidelines to accurately abstract and enter cancer cases in the registry database to include patient demographics, diagnostic procedures, history and extent of disease, treatment, follow-up, physician and related information and codes the registry data according to strict protocol requirements. Organizes and manages case finding and death certificate follow-up of all reportable neoplasms and update cases to include treatment data of second primaries. Gathers and analyzes data to assess community needs and performance, effectiveness, and impact of programs and policies. Provides technical assistance and consultation to reporting facilities, health systems, clinics, other health care providers and internal DC Health programs related to data collection, analysis, and reporting. Writes proposals, grant applications, and other required materials, specifically epidemiologically focused; submits all grant applications in a timely manner.

Leads the analysis of DC Cancer Registry data and other large datasets such as Behavioral Risk Factor Surveillance System (BRFSS) and provides reports to the relevant programs. Leads the development and consistent updating of cancer fact sheets, reports, websites, and other dissemination products. Reviews submitted data for completeness and accuracy and follows up with data sources as necessary (e.g., BRFSS). Serve as a team lead and periodically as multi-agency team leader or project manager. May serve a team lead for interns and fellows. As required, collaborates with other programs within the department to leverage program activities. Develops bureau data plans, reports, and factsheets for dissemination to program staff and key stakeholders. Prepare periodic and ad-hoc reports regarding data activities. Determines the availability and adequacy of data sources to support cancer and chronic disease prevention programs and

in producing reports with data that can be used in program planning, development, monitoring, and evaluation activities.

Qualifications and Education

Individuals must possess at least one (1) year of specialized experience equivalent to at least the next lower grade (12) level in the normal line of progression for the occupation in the organization. Specialized experience is defined as experience that is typically in or related to the work of the position to be filled, and has equipped you with the particular knowledge, skills, and abilities to successfully perform the duties of the position, and that is typically in or related to the work of the position to be filled.

Based on the duties and responsibilities of this position, a minimum of a Masters of Epidemiology or a Master of Public Health (MPH) or equivalent degree is preferred for the incumbent of this position.
