

2023 Annual SEER Workshop Advanced Topics for Registry Professionals December 5-7, 2023

The *free* workshop is open to *all* cancer registrars and will be held virtually on Tuesday-Thursday, December 5-7, 2023 from 12:00-4:30 PM EDT. The goal of the workshop is to expand registrars' knowledge of several important topics including in-depth coding for LAMN/HAMN, extra- and intrahepatic bile ducts, and oropharyngeal cancers and more. There will be presentations from subject matter experts including surgeons, pathologists, and oncologists.

Participants are asked to *complete coding exercises by 11/10/23* for Brain (site/histo/behavior), Other Sites (site/histo/behavior), and LAMN/HAMN (EOD/Summary Stage/SSDI) in SEER*Educate in order to assist Carolyn Callaghan, one of the workshop speakers, in preparing her presentations. She plans to highlight the observed challenges associated with interpreting medical transcripts to achieve coding accuracy and consistency when applying rules and guidelines outlined in the manuals.

As of Friday, 10/27/23, nearly 1,600 have registered for the upcoming workshop. We want to thank all who completed the coding exercises. If completing the cases prior to 11/10/23 doesn't work for your schedule, please try to complete them prior to the Workshop so you get more benefit from the sessions covering those topics. You will earn CEs, whether you complete the cases before or after November 10th, but completing them before the 10th will allow Carolyn to better focus the presentations. There isn't enough time to walk through each case during the workshop. Instead, she will focus on explaining the trends that resulted from the participants initial responses.
