Final Four Mash-Ups



These are the final 4 primary sites that make up the "Mash-Up" coding practice series. There is a total of 295 cases in this series which is intended to assess the coding accuracy for the Dx Year 2021–2023 changes to EOD, Summary Stage, Grade, and SSDI. The final 4 new sites each have 5 practice cases to assess one's personal coding accuracy and the consistency in applying the coding guidelines among an entire staff. This coding practice series qualifies for free Category A continuing education (CE) credits approved by NCRA. The number of CEs awarded is based on the average time it takes to code the cases and review the answers and corresponding rationales.

The number of **free Category A CEs** awarded by NCRA for completing any training module discussed in this announcement is indicated on of the grids below.

There are a total of 17 free Category A CEs available for this release. The Program Recognition numbers to use when preparing your biannual CE submission are also provided to facilitate completing the NCRA documentation required to maintain your CTR credential.
